SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Skin and serious eye damage, corrosion or irritation (Category 2, 2A). Causes skin and serious eye irritation (H315+H319).

Hazard class: Germ cell mutagenicity (Category 1A). May cause genetic defects (H340). Obtain special instructions before use (P201). Do not handle until all safety precautions have been read and understood (P202). Use personal protective equipment as required (P281).

Hazard class: Carcinogenicity (Category 1). May cause cancer (H350).

SECTION 4 — FIRST AID MEASURES

If exposed or concerned: Get medical advice or attention (P308+P313).

If inhaled: Remove victim to fresh air and keep at rest in a position comfortable for breathing (P304+P340).

If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do so. Continue rinsing (P305+P351+P338). **If eye irritation persists eyes:** Get medical advice or attention (P337+P313).

If on skin: Wash with plenty of water (P302+P352). **If skin irritation occurs:** Get medical advice or attention (P332+P313).

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Inorganic #9. Store with acids, except nitric acid.

Store in a dedicated acid cabinet and away from any source of water; if an acid cabinet is not available, store in Flinn Safe-Cube™.

Wear protective gloves, protective clothing, and eye protection (P280). Wash hands thoroughly after handling (P264).
